- 2. It's imperative to highlight that all appointments to our esteemed Governing Body are honorary positions and will be valid for three years from the date of release of this order
- 3. The membership of the Governing Body will cease upon the occurrence of any of the following events:
- i) Expiry of the prescribed membership period as mentioned above.
- ii) Death, resignation, insolvency, lunacy, or conviction for a criminal offense or moral turpitude.

- iii) Voluntary withdrawal from serving on the Governing Body or refusal of permission from the employer to serve.
- iv) Failure to attend three consecutive meetings of the Governing Body without prior leave of the President.
- 4. The decision of the President regarding the termination or removal of any member shall be considered final.
- 5. Meetings of the Governing Body will be scheduled as determined by the President, with due consideration given to date, time, and venue.

We extend our gratitude to all members for their dedication and commitment to advancing the objectives of PEFI.
